Moderator's Invitation to VMC Winter Assembly

January 1, 2023

Dear VMC family,

We will discuss and act on two proposed by-law changes: to involve youth delegates in our annual assemblies; to reorganize conference council for greater diversity of gifts and perspectives. We will hear reports from the interim Conference Leadership Team, the Racial Justice Task Force, VMC's treasurer, and VMMissions. We will have opportunity to elect a moderator elect and others gifted to serve. We will release one precious VMC congregation. And we will hear about inspired ways to live into VMC's strategic missional priorities.

I invite us to pray for each other and for our conference assembly—that the illuminating Holy Spirit will guide us. And to paraphrase Psalm 51: that transgressions will be named; that we will hear truth in our inner beings and learn wisdom in our hearts; that we will be washed and made clean so the bones that have been crushed will rejoice; that we will be freed to experience joy and gladness.

Virginia Mennonite Conference

Session 1 (RE)ALITY CHECK

1. Welcome. Sara welcomed the group and expressed gratitude to the vision team for the work of planning the assembly. She read Psalm 133 expressed her hope for a gathering in the spirit of this text.

1 How good and pleasant it is when God's people live together in unity!
2 It is like precious oil poured on the head, running down on the beard, running down on Aaron's beard, down on the collar of his robe.
3 It is as if the dew of Hermon were falling on Mount Zion.
For there the Lord bestows his blessing, even life forevermore.

- 2. **Greetings**. Pr. Sarah Piper extended greetings from Zion Mennonite Church and noted that although Zion has hosted the summer assembly 14 times beginning in 1887, this was the first time since 1965 that the delegates have gathered here for the event.
- 3. **Introduction of Theme.** Moriah Hurst, with help from an overburdened traveler played by June Miller, presented the "(RE)PACKING" theme and invited table group members to introduce themselves to each other by reflecting on the things that we carry; are they useless baggage or useful luggage.
- 4. **Music and worship.** The group engaged in a meaningful time of worship lead by Chad Miller, Mackenzie Miller and Christa Hoover.
- 5. **Stories.** Sarah Piper, Gerald Shenk and Alfonso Alavarado Ayala, Pastor of Iglesia Mennonita Monte Moriah in Rockingham Ct. VA, told stories of hope in times of uncertainty and anxiety.
- 6. **Reflection and Scripture.** Lorie Friesen shared reflections on Luke 10:1-9 focusing on vs 4 as a metaphor for a tendency to 'overpack" and take more than we need in the journey of sharing the good news.
- 7. **Table Groups** spent about an hour reflecting on Lori's presentation.

11:30 a.m. VMC Business Session

- 1. Moderator's Report Sara summarized Conference Council's (CC) work over the last few months. She and Jim Hershberger, CC Secretary meet monthly with Joe Longacre, FLC chair and Pearl Hoover, FLC vice chair, to discuss conference issues. Sara values the opportunity for increased communication with the Faith and Life Commission. Based on District feedback, CC is enlisting the aid of a consulting group to work with a group of 12 VMC persons to resolve on-going issues of trust and accountability that culminated with the resignation of Clyde Kratz, Executive Conference Minister, in March of 2022. There is a committee reviewing VMC bylaws in the event of restructuring VMC governance bodies. The Interim Conference Leadership Team is in place and will meet in August to get organized.
 - **2. Approval of Minutes** In the absence of Jim Hershberger, CC Secretary, Sara reviewed minutes from the Winter Delegate Assembly on February 5, 2022

Action 1. That the minutes of the February 5 Winter Delegate Session are approved. PASSED.

- **3. Finance Report.** Leroy Kauffman, CC Treasurer, referenced his written report that covers September 1, 2021, through May 31, 2022. He is deeply grateful for those that provide resources. He noted that although revenue is less than hoped for, expenses are down also.
 - **4. Nominations.** Steve Carpenter, Chair of Gifts Discernment, reported that he has "termed out" and Howard Miller, pastor at Huntington Mennonite in Newport News, VA is joining the committee. Glen Kauffman, committee member, will serve as chair. Steve introduced the current slate of candidates: Jim Hershberger, second three-year term as secretary and Theresa Shifflett, second three-year term on the Congregational Life Commission. There are still vacancies on Gifts Discernment and Congregational Life, and he invited suggestions to fill these roles.

Vote Results: Jim Hershberger was affirmed for another 3-year term as CC Secretary and Theresa Shifflett was affirmed for another 3-year term on the Congregational Life Commission.

5. Blessing Zion Hill Mennonite: James Ackerson, District Minister for Central District, expressed regret that Zion Hill was leaving VMC but is greatful that the separation was amicable. James led in a prayer of blessing for the church.

Session 2 (RE)CLAIMING THE SHARED VISION Friday, July 15, 1:00 p.m.

- Guest Introduction. Sara introduced these guests and others Rachel Miller, MC USA Ministerial Leadership, Eric Frey Martin, MMN Constituency Engagement Representative, Bob Yoder, AMBS Development Director, Lana Miller, Everence Stewardship Consultant, Pam Miller, Pleasant View Inc, Development Director, Luke Schrock-Hurst, MCC, Paul Layman, Eastern Mennonite School, David Gingerich, VMMissions Congregational Representative, Elwood Yoder, VMC Historian.
- 2. Music and Worship. Chad Miller and Mackenzie Miller, Leaders
- 3. Stories
 - MC USA Report Back VMC delegates to the MC USA special assembly, Mary Beth Moore, Marian Buckwalter, Andrew Cheung and Andrew Buckwalter Fairfield shared stories of their engagement at the assembly.
 - Vision for Youth Moriah Hurst reported that the Youth Council has been keeping youth events going with a view toward a larger goal of fully incorporating youth, ages 16-25 in VMC. She pointed out that this level of engagement does not just happen, it needs education, mentoring and cultivation to flourish.
 - Racial Justice Task Force Caleb Schrock-Hurst, RJTF director, referenced his
 recent trip to Mennonite World Conference in Indonesia as an illustration of how
 the Anabaptist understandings of following Jesus can transform cultural barriers
 of fear and mistrust into bridges of understanding. RJTF has engaged with most
 Districts in the IDI training. The task force has sponsored and are planning
 several racial justice events in the Harrisonburg area and beyond. Much of the
 RJTF work falls into the following actions:
 - 1. Change the narrative, speak the truth
 - 2. Stay hopeful, this is long-term work
 - 3. Be uncomfortable, stand with the least
 - 4. Prioritize proximity

Following Caleb's presentation, the table groups convened to reflect on 3 questions: What resources and actions are your faith community involved in? How is your faith community taking advantage of proximity? What barriers is God calling you to cross and what is preventing you from crossing them.

- 4. **Reflection and Scripture, Mary Beth Moore, Lori Friesen.** Mary Beth led a guided reflection on Luke 10:1-9 and invited the group to imagine themselves as one of the 70 that was sent out or as one of the villagers. Lori asked the group to consider how we have become sidetracked from the primary mission of sharing the good news with neighbors, near and far. Do we see ourselves as gatekeepers or emissaries of good news.
- 5. Table groups spent an hour or so reflecting on the scripture and reflections.

Session 3 (RE)NEWING RELATIONISHIP Saturday, July 16 8:30 A.m.

- 1. Welcome and prayer Sara welcomed the group with Psalm 133: "How very good it is..." and shared some of her call to moderator. Some would characterize the role with the metaphorical expression "stepping into minefield". Although there have been many challenges, Sara sees the space, not as a terrain with hidden dangers but as a place too discover a hidden treasure trove. She concluded by asking persons to voice single words or short phrases that represented valuable take-aways from the assembly. Sara closed by acknowledging the indigenous folk who once lived on this land and had prayer.
- **2. Strategic Plan Action Steps** Sara Bixler, FLC Cluster Leader of Ordained Teachers, outlined the strategic plan action steps that FLC is recommending for faith communities, Districts and assembly planners and encouraged engagement with them. (See Attachment)
- 3. Interim Conference Leadership Team (CLT) CLT members, Caleb Schrock-Hurst (expanded role as RJTF leader), June Miller (Director of Communication and Administration), Craig Maven (Church Relations), Maren Hange, (Formation and Soul Care), Bishop Leslie Francisco, (Diversity and Inclusion) and Duane Beck, (Consulting with Pastors) shared a brief statement of call and vision. The team will be meeting in August to finalize assignments.
- 4. **Music and Worship.** Chad Miller, Mackenzie Miller and Crista Hoover, leaders.
- **5. Reflection and Scripture** Lori reviewed her presentations and expressed her hope that VMC can go forward, without baggage, with urgency and a spirit of healing and being with, proclaiming "The Kingdom of God has come near to you".
- **6. Table Groups** The table groups convened to discuss what was presented.
- 7. Commissioning

Hello my kindred in Christ,

I was born and raised in Rockingham County; some of my earliest memories are of Park View Mennonite Church and the friends I made there. I attended Eastern Mennonite High School and then Goshen College, graduating in the spring of 2007 with majors in Spanish and Bible & Religion and in the summer marrying Molly Buckwalter, one of those friends from Park View.

By 2010 we'd been married long enough for Mennonite Central Committee to consider taking us on as service workers, and we shipped out to China under a secondary organization, Mennonite Partners in China. There we were trained to teach English at the college level for students whose English abilities were very adept at taking tests but

very inexperienced at actually communicating. After two years of teaching in Sichuan Province, MCC and MPC kindly gave us a six-month hiatus to study Mandarin full-time at the Sichuan University of Finance and Economics in Chendgu. After that, our third year of service was spent in Nanjing volunteering to provide translation and English-language communications for Wang Xuefu, a Christian psychotherapist and author whose work at healing generational trauma in Chinese churches has been supported by MCC.

Before China I had begun classes at Eastern Mennonite Seminary. As we prepared to return in 2013 I applied to a variety of schools to finish my MDiv, and finally settled on Princeton Theological Seminary. At that point I had about a decade of Mennonite education under my belt, and thought I might serve the Church better with at least a bit of exposure to other denominations. After 2 years I had finished my degree but Molly was halfway through hers, so we moved to Menno House on 19th St. in Manhattan for her to complete her Master of Public Administration at New York University. We had our first child, Simon, in New York that fall. In the spring Molly graduated and that summer we moved to Christiansburg, Virginia, where I have served as pastor for the five years since. Here we have been joined by a daughter, Sarah, in 2018, and a second son, Moses, this year.

It's an honor to be asked to serve as Moderator-Elect for Virginia Mennonite Conference. It's a conference that I grew up in, that I have a great deal of affection for and loyalty to. I've seen so much Kingdom work done through VMC, and experienced so many joyful moments. I realize there are plenty of folks who've had much more negative experiences than I, but if I can be a small part of building VMC towards its "higher calling of God in Christ Jesus" (Phil. 3:14) then I am eager for the task.

Section 5. Meetings

Section 6. Motions

Delegates may submit motion(s) for consideration by assembled delegates, via Conference Council, in advance of Assembly or the Winter Delegate Session. All motions must be signed by at least 3 delegates and be received by the moderator no later than the day before Conference Council meets. Motions made from the floor may be received for consideration but may only be acted upon at the next delegate assembly.

Section 7. Decision Making

- 7.1 Each delegate shall be eligible to cast one vote. There is no provision for proxy voting.
- 7.2 A majority of votes cast shall determine any matter, except when the Assembly agrees otherwise or when otherwise provided in the Constitution or By-Laws.
- 7.3 Forty percent (40%) of delegates shall constitute a quorum. Approval of actions shall require a simple majority of those present.

Strategic Plans: History and Mystery

Strategic planning, which came into common business use in the 1960's, is a process in which an organization defines its vision for the future and identifies its organizational goals and objectives. The process often establishes the sequence in which those goals should be realized.

Once a strategic plan is created, the next step is—you guessed it—an action plan. An action plan puts your strategy into the heads, hearts, and hands of the people who will make a real, measurable difference by implementing your strategic plan

Strategic planning is not limited to secular organizations. Here is the timeline for the origin and next steps of VMC's Strategic Plan:

- June 2020 A Strategic Plan was developed and recommended to the delegates of VMC by a Task Force comprised of James Akerson, Deb Horst, Moriah Hurst, Clyde Kratz, Armando Sanchez, David Brubaker (facilitator), with input from Pearl Hartman & Aldine Musser during sabbaticals of Deb Horst and Moriah Hurst.
- February 2, 2021 Following a few suggested revisions the Plan was adopted at our Winter Delegate Assembly. The VMC Mission Statement, Vision Statement, and Values Statement were included in the motion adopting the 5 Priority Goals (2021 2025), which can be accessed on the VMC website at virginiaconference.org, under Resources.
- November 10, 2022 The Faith and Life Commission, which had been asked to develop Action Plans for the 22 Objectives for the 5 Goals, delivered them to Conference Council as requested.
- February 4, 2023 (Our Winter Delegate Session) A sample of the completed action plans will be introduced to the delegates, along with a spontaneous expression for their need, heard from one of our pastors.
 - Because of other urgent business at our Winter Delegate Session, we will not have time to present and discuss the Action Plans in full, but you will see an example or two of how they will work and hear from a pastor regarding how eager they are for these aids in implementing our Goals.
- Spring and Summer, 2023: The Faith and Life Commission will oversee dissemination of the various Action Plans to appropriate individuals and organizations within the Conference, monitor responses, and suggest adjustments.

the exchange

A Virginia Mennonite Conference congregation that has been part of Northern District, the exchange, located in Winchester and pastored by Chris Scott has informed us that they are moving their membership from VMC to Allegheny Conference. We have had the privilege of walking and working with Chris through the church planting and congregation-in-formation stages of their development and growth.

In a letter to the District ministers and Sara Wenger Shenk on June 19, 2022 they stated that, "we believe it is time for the exchange to exit Virginia Mennonite Conference as a congregation and realign our community with the Allegheny Conference. Allegheny seems like a much better fit for the exchange. At the exchange, we support the full inclusion of LGBTQIA persons in our church's whole life, ministry and ordinances. It does not seem that VMC does, or ever will".

The conference leadership's slow, or lack of processing the implications of the resolutions passed in Kansas City in May is also cited as a reason for their decision to leave at this point. "Esteem for those of us who hold progressive views is virtually non-existent in VMC". The letter also describes painful relationships they have experienced within VMC that included name-calling.

The letter concludes by stating, "we don't see anything changing in VMC's exclusionary approach to our LGBTQIA siblings, and so this is where the road divides for us to authentically be the congregation that God is calling the exchange to be. We have loved our time in Virginia Conference, but it would not be in anyone's interest for us to remain. Our leaving is a move from pastoral faithfulness and ministry commitment. Listening to the Holy Spirit is what causes us to go. Thank you for the support and connection. We wish you well".

Chris shared at our last Northern District meeting on behalf of the congregation. In response, we gathered around Chris (and the exchange) and offered prayers of support, lament and blessing.

Conference Council has processed this information and will provide time and space at the Winter Delegate Assembly to acknowledge the ministry of the exchange in VMC and offer prayers of support, lament and blessing.
